3. **MINUTES OF LAST MEETING HELD 5th OCTOBER, 2018**

4. **MATTERS ARISING FROM THE MINUTES**
 - **Cemetery** – clerk has had contact with the family regarding the kerbstone. Undertaker to take away the kerbstone, but to contact with the family before starting the work.
 - **Eisteddfod yr Urdd 2020 Appeal** – The community Council to arrange a Public Meeting at the Ganolfan on the 15th November at the Ganolfan.
 - **Style at Y Wern** – a kissing gate has replaced the old style
 - **Bro Dinam Path** – workers have repaired part of the pathway.
 - **Woodlice Problem at Bro Dinam** – Nothing has been done to date – Clerk to contact Denbighshire and contact Mabon.
 - **Church Flood Lights** – Clerk has contacted Dylan Jones, Corwen. Willing to check lights and see if it is possible to adapt to LED lights.
 - **Tree at Bro Dinam** – no work has been done on the rotting tree. Rhiannon to contact the Carnival Committee to erect a Christmas tree at Bro Dinam, Community Council to cover the cost of tree.
