Mae Cyngor Sir Ddinbych yn bwriadu gwneud Gorchymyn ddim cyn 7 diwrnod o 29 Ebrill 2020, sy'n gwahardd unrhyw gerbyd rhag teithio ar hyd y rhan honno o'r ffordd a elwir yn B4401 Llandrillo yn Sir Ddinbych sy'n ymestyn o'r gyffordd â Stryd y Berwyn i'r gyffordd â Phont yr Hendwr i Tyn y Parc. Mae angen cau'r ffordd er mwyn i BT Openreach ymgymryd â gwaith cynnal a chadw.

Bydd y llwybr amgen wedi'i arwyddo ac yn mynd ar hyd y B4401, B4402, A494 a'r A5. Bydd mynediad i gerddwyr trwy gydol y cyfnod cau.

Bydd y Gorchymyn yn weithredol o 18 Mai 2020 am gyfnod o ddeunaw mis neu lai, hyd nes y cwblheir y gwaith, pa un bynnag sydd gynharaf.

Bydd y ffordd ar gau dros nos yn unig, rhwng 21:00 a 06:00. Ar bob adeg arall, caniateir i gerbydau barhau i ddefnyddio'r B4401 fel arfer.

NOTICE OF TEMPORARY TRAFFIC ORDER

Notice of Temporary Prohibition of Through Traffic Order

Road Traffic Regulation Act 1984 - Section 14

Denbighshire County Council intends not sooner than 7 days from 29th April 2020 to make an Order prohibiting vehicles using that length of B4401 Llandrillo in the County of Denbigh which extends from its junction with Berwyn Street to its junction with Pont yr Hendwr to Tyn y Parc. The closure is necessary to facilitate maintenance works by BT Openreach.

The signposted alternative route will be via B4401, B4402 A494 and A5. Pedestrian access will be maintained throughout the period of closure.

The Order is effective from 18th May 2020 for an eighteen month period or the earlier completion of the works whichever is soonest.

The closure will only be in place overnight, between 21:00 and 06:00. At all other times vehicles will be able to continue using the B4401 as normal.

The works are expected to last approximately until 23rd May 2020.
